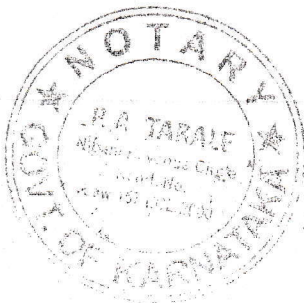
- 1) To appoint M-Pharm (Ist Class) Five Lecturers.

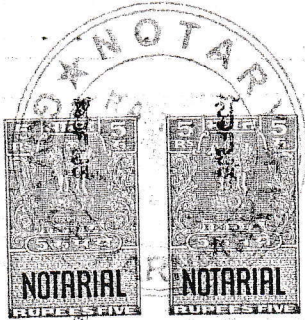
