Sir/Madam

With reference to the subject cited above, I am directed to inform that considering the latest information on record, 77th Central Council of the PCI in its meeting held on 17th & 18th August, 2006 has decided to grant approval from 2004-2005 to 2007-2008 academic session for 60 admissions for the conduct of Ist, IInd, IIIrd & IVth year B.Pharm course.

It was also decided to instruct the institution --

- that every year it has to apply to PCI in the SIF for the conduct of early inspection for year-wise approval or rejection of approval on the basis of which the institution can make further admission/no admission. When the students are in the final year B.Pharm an inspection will be conducted by PCI for consideration of approval of B.Pharm course u/s 12 of the Pharmacy Act for the purpose of registration as pharmacist and institution shall intimate the date of final year examination.
- to comply with the requirements of Education Regulations, 1991 particularly regarding appointment of teaching staff and equipments.
